**Subject:** Cervical Cancer Screen Provider Pocket Guide

**Summary:** A resource that can be utilized as a pocket guide reference for prevention measures: Cervical Cancer Screening (CCS)

The provider pocket guide below provides a quick tool for reference for cervical cancer screening (CCS) guidelines by age, documentation guidelines to ensure measures are captured during HEDIS auditing and exclusion coding/documentation for patients who DO NOT require cervical cancer screening. The following can be cut and folded to fit conveniently in the provider's pocket.

Age	Recommendation
9-26	✓ HPV vaccination recommended
21-29	✓ Cytology alone every 3 years
30-65	✓ Cytology alone every 3 years
	✓ hrHPV testing alone every 3 years
	✓ hrHPV testing and cytology every 5
	years

## **Documentation Required**

- A note indicating the date when the cervical cytology was performed and the findings.
- A note indicating the date hrHPV test was performed and the findings.

NOTE: Evidence of hrHPV testing within the last 5 years also captures patients who had co-testing.

### **CCS Exclusion Codes**

When coding for patients who have the following diagnosis and **do not need PAP** testing/cervical cancer screening, please use codes below:

\*Document evidence of a hysterectomy with no residual cervix; specify "complete," "total," "radical," "total abdominal," or "vaginal" hysterectomy, "cervical agenesis" or "acquired absence of cervix"
