Subject: Request for Applications for Adult and Youth Louisiana Crisis Response System (LA-CRS) Training for Mental Health Providers

Summary: The information below is being shared at the request of the Louisiana Department of Health (LDH), the Office of Behavioral Health (OBH), in partnership with the Center for Evidence to Practice regarding the new Youth Louisiana Crisis Response System Training and the Louisiana Adult Crisis Response System Mental Health Provider Training.

What is this Request for Application for?

The Center for Evidence to Practice, in partnership with the LDH-Office of Behavioral Health, is seeking qualified applicants who demonstrate the most readiness to participate in crisis response training for the newly developed Youth Louisiana Crisis Response System (LA-CRS) and the Adult Louisiana Crisis Response System.

Completing this training is required to seek credentialing and contracting with AmeriHealth Caritas Louisiana and other Louisiana Medicaid Managed Care Organizations, which is a separate step in beginning to deliver services.

Who can apply?

The application for the Youth Mental Health Crisis Response System Provider Train is only open on a rolling basis for Regions 7 and 8. Applications for other regions are not being accepted at this time.

The Louisiana Adult Crisis Response System Mental Health Provider Training application is accepted on a rolling basis for regions and services needed.
